

BECKMAN ORAL MOTOR ORO-FACIAL DEEP TISSUE RELEASE COURSE

Course Description: The two-day Beckman Oral Motor Assessment & Intervention course is a pre-requisite to the Oro-facial Deep Tissue Release course.

This is a one-day hands-on intensive workshop. During this course, participants will practice specific deep tissue release for the upper and lower lips, upper and lower cheeks, midface, jaw, and tongue. These interventions focus on increased range of movement for these structures. In addition, participants will have the opportunity to review, discuss and practice the Beckman Oral Motor Assessment and Intervention protocol. Participants are welcome to discuss specific issues they encounter in their practice and determine if and what Beckman Oral Motor interventions may be beneficial in improving oral motor function and what other resources, methodologies, products or services might enhance a positive outcome of therapy. Participants are invited to bring video case studies on DVD for discussion and problem solving.

- ❖ Demonstrate intervention options for mobility of the lips, cheeks, midface, jaw and tongue using deep tissue releases.
- ❖ Problem solve issues regarding client specific oral motor and mealtime concerns.
- ❖ Demonstrate oral motor assessment and intervention techniques as determined by the participants.
